SHOW APPROVAL APPLICATION

The members of the BC Paint Horse Club (BCPHC) are committed to promoting the American Paint Horse throughout British Columbia. The board of directors encourages any group interested in hosting an APHA-approved show to seek BCPHC approval. The club's direction and policy regarding show or event approval is to include and recognize the efforts of local organizing committees to promote APHA activities while allowing them the autonomy to be in control of their own success. BCPHC show approval will enable all exhibitors who are BCPHC members to be eligible for BCPHC year end awards, provide liability insurance coverage to show organizers if required, and offers added incentives for more Paint Horse exhibitors to participate at your show.

The BC Paint Horse Club is not involved in the decision-making process of the proposed show other than the initial approval, but can provide management support to the organizing committee on request. We will actively help promote your APHA show to our members by email, to Paint Horse owners throughout the Pacific Northwest on our website and to horse owners through western Canada in our monthly column in *Saddle Up*. FEES:

When liability insurance coverage is required:

- 1) A show approval fee of \$125 for a 1 day show, \$200 for 2 consecutive day show, and a maximum of \$250 for a 3 (or more) consecutive day show, to be remitted with show approval application.*
- 2) A \$1 per entry (in each class) per judge levy applicable to all APHA classes to be remitted within 30 days after the close of the show.

When no liability insurance coverage is required:

- 1) A show approval fee of \$62.50 per judge, to be remitted with show approval application.
- 2) A \$1.00 per entry (in each class) per judge levy applicable to all APHA classes to be remitted within 30 days of the close of the show.

*A copy of the organizing committee's certificate of insurance that indemnifies the BC Paint Horse Club and its directors and members from damage, loss, injury or death related to the show to accompany the application.

- The BC Paint Horse Club and/or its board of directors does not assume any financial risk in the organization or outcome of the approved show.
- The application for show approval must be accompanied by the show approval fee no less than 45 days before the show date.
- Shows are encouraged to co-ordinate their judge selection so the same judge isn't officiating at more than one show in BC in the same year. Duplicate judges in the same year are not permitted at NWCC-approved shows.
- The entry levy must be remitted in full with a copy of the APHA show results to the BCPHC treasurer within 30 days following the end of the show. Failure to do so may result in a forfeit of points earned by exhibitors for BCPHC year end tabulation.
- The BCPHC's logo is available on request for use on show premiums and advertising.
- The BC Paint Horse Club may be able to assist with liability insurance coverage for organizations or committees interested in hosting an event such as a trail ride, a schooling show, a clinic, a barbecue, a games day, or a working ranch horse competition. Please contact the treasurer for information.
